- ➤ Rebecca provided a summary background on the Green Budget (Appropriations document where a broad coalition of national environmental/conservation groups) lay out the majority of the environmental and conservation program the larger whole supports.
 - American Forests has led the urban forestry portion for several years, using SUFC talking points for a baseline coordinated message; leveraging greater impact of the sector.
 - Past budget documents have been more inspirational in nature but the last year the goal was to "hold the line."
 - This year the approach is to reflect the results/outcome of reduced funding on the ground. This is a stronger message on the Hill with the threat of sequestration.
 - Copies of the document will be available for distribution for all interested SUFC members. This CAN be used on the Hill but fully optional. The Green Budget may have a new title this year such as the "Sequestration Budget."
 - All SUFC members have the opportunity to sign onto the Budget if interested (individually).
